The Challenges

- Legacy System
 - Confusion and rework caused by manual processes
 - Cumbersome Risk Management processes

- Manage complete risk assessment lifecycle
 - Risk recording, assessment, analysis, monitoring & mitigation
- Enable 'Weightage Risk Scoring' approach
 - Tracking risk metrics and thresholds
 - Highlighting key regions to be focused on
- Provide real-time risk insights to executives and stakeholders
 - Dynamic dashboards & heat maps enabling informed decision making
- Ensure closed loop issue remediation
 - Easing the tracking process

- MetricStream cloud infrastructure ensuring easy installation




Risk Register Dashboard

Top 20 Organizations (By Residual Scores Based On Rolled Up Score)




Top 20 Entities (By Residual Scores Based On Rolled Up Score)





Inherent Risk Breakdown (by Risks)


Residual Risk Breakdown (by Risks)






of Key and Non-Key Controls Assessed




of Controls by Rating

of Controls Assessed per Organization (Top 20)







